

**60th? Annual Francis T. Bradbury
Memorial Long Distance Pursuit Race
July 4th, 2022**

SAILING INSTRUCTIONS

1. RULES:

- 1.1. The race will be governed by *The Racing Rules of Sailing (RRS)*, the Prescriptions of US Sailing, rules of the PHRF of Eastern Connecticut and the rules of participating one-design classes.
- 1.2. Rules of the road provide commercial traffic with the right of way in a restricted channel. **Failure of a racing boat to keep clear, whether intentional or not, will result in disqualification.**
- 1.3. Time-on-Distance handicapping will be used for PHRF classes.
- 1.4. US Sailing sail numbers of rule 77 and appendix G are not required.
- 1.5. There will be **one class**.
- 1.6. The Start will be a reverse start with the boat with the highest PHRF handicap starting first and each additional boat starting based on their PHRF from highest to smallest. Starting times will be given sent to competitors.

2. ENTRIES:

- 2.1. Entries will be accepted or rejected and assigned to classes at the discretion of the Race Committee (RC). Skippers of record must be members of the Thames Yacht Club.
- 2.2. Class assignment and handicaps will be based on the PHRF of Eastern Connecticut. At the discretion of the RC a handicap will be assigned to a boat without an established rating.

3. CHANGES TO THE SAILING INSTRUCTIONS:

- 3.1. Any changes to the Sailing Instructions will be posted on the Racing Information bulletin board prior to 0930 if the first Warning Signal is not delayed.

4. SCHEDULE OF RACES & THE START:

- 4.1. The first start will be at 10:30AM.
- 4.2. One race of 12 NM in length is scheduled.
- 4.3. Boats who are more than 5 minutes from starting shall keep clear of the starting area. **Failure to comply may result in disqualification.**
- 4.4. Boats will start any time after their designated start time listed below.

5. COURSE:

5.1. The course will be **I (starboard)- X (starboard)- S (starboard) - J (port)** That means you pass

I - red/green can at Intrepid Rock

X- Red bell buoy at North Hill on Fisher's Island

S- red/green can at Sarah's Ledge

J- green can at Junk Island

then back to starting/finishing line

Record the time of day when you cross the finish line and the boat in front and behind you if any and bring it to the club or text it to Dave Knecht at 860-465-7618

6. FINISH:

6.1. The finish line will be between a staff displaying an orange flag on the Queen Merry and a finishing mark east of the Queen Merry.

6.2. Each vessel should record its own finish time and report that time to the Rear Commodore in person, by text or email.

6.3. Boats unable to finish are instructed to notify the RC before retiring from the race course on VHF 72.

9. TIME LIMIT: The time limit for each class to finish is 1530, Any boat not finishing within this time will be scored DNF.

10. RADIO COMMUNICATIONS:

10.1.VHF-FM Channel 72 will be used for communication between the race committee and competing boats.

11. PROTESTS:

11.1. A boat intending to protest shall follow Rule 61.1. A written protest shall be delivered to a race official at the clubhouse within one hour after the RC comes ashore.

11.2. Notices of protest hearings will be posted on the Racing Information bulletin board. It is intended that any protest be heard as soon as feasible after the day's racing. Failure of either party to appear may result in a judgment against the absentee.

12. SCORING:

12.1 The race will be scored based on the order of finish.

13. AWARDS:

13.1.Race results will be announced at the Clubhouse after the race is completed.

13.2.Trophies will be awarded to the 1st, 2nd and 3rd place boats. Trophies will be awarded at Skippers' Night, at the TYC clubhouse.

14. DISCLAIMER OF LIABILITY:

14.1.Competitors participate entirely at their own risk; see Rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.
